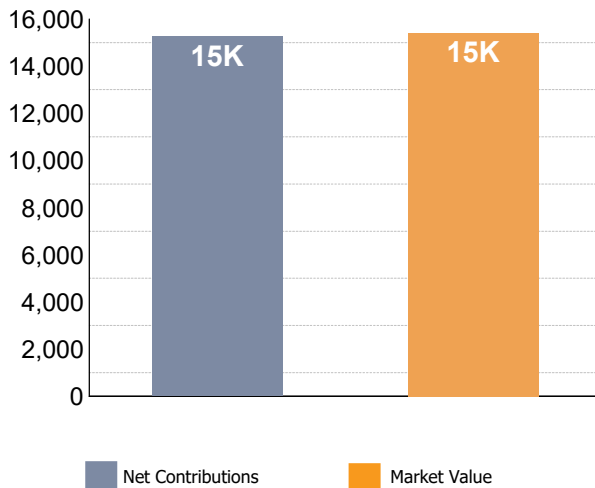

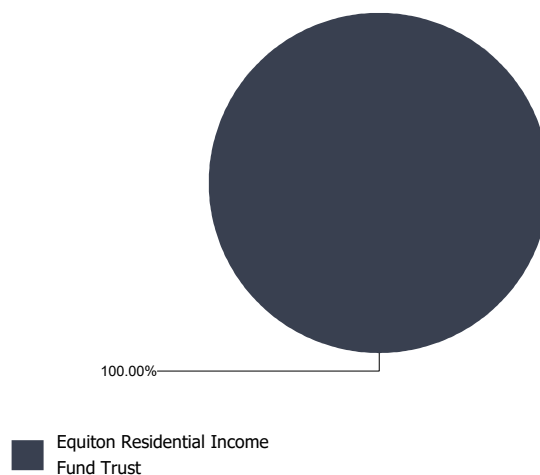

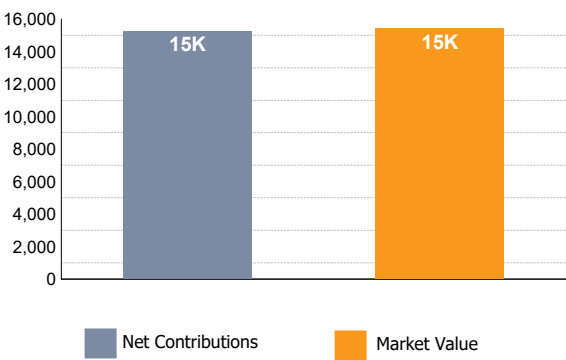


Product Investment Breakdown
